Further to its Broadcasting Notices of Public Hearing CRTC 2007-7 dated 21 June 2007, 2007-7-1 and 2007-7-2 dated 3 and 10 July 2007 relating to a Public Hearing which will be held on 27 August 2007 at 9:30 a.m., at the Conference Centre, Portage IV, 140 Promenade du Portage, Gatineau, Quebec, the Commission announces that it will also consider the following application.

The deadline for submission of interventions/comments, for the following application only, is **2 August 2007**.

25. Peterborough, Ontario Application No. 2006-1458-8

Application by **Trent Radio** to renew the licence of the community-based campus radio programming undertaking CFFF-FM Peterborough, expiring 31 August 2007.

This application has already been gazetted in Broadcasting Public Notice CRTC 2007-31 (PN 2007-31).

PN 2007-31 noted that CFFF-FM had advised the Commission that its association with Trent University may have been non-existent and that its board of directors did not include representation from the university as identified in the Campus radio policy (Public Notice CRTC 2000-12).

In light of this information, the Commission is considering a change to CFFF-FM's class of licence from a community-based campus to a Type B community radio programming undertaking under the terms and conditions set out in the Community radio policy (Public Notice CRTC 2000-13) and new licence form for community radio stations (Public Notice CRTC 2000-157).

The licensee has indicated that it would be ready, if the Commission deems appropriate to proceed with a Type B community licence, to carry out this change of class of licence.

Trent Radio would operate its Type B community radio station under the same technical parameters as presently authorized.



This change in class of licence would require the issuance of a new licence and therefore must be processed via public hearing as required by Subsection 18 (1)(a) of the Broadcasting Act.

Should this change of class of licence be approved, Trent Radio's community-based campus radio programming licence will be revoked.

The Commission will consider the interventions already received, accepted and filed on the public file for Public Notice 2007-31 as well as other interventions received in the context of this Public Hearing.
