PREAMBLE

The Commission would like to point out that it will consider the radio applications for the Drumheller and Red Deer markets during the week of 27 May 2008 and those for the Edmonton market during the week of 2 June 2008.

Items 1 to 26

On 14 November 2007, the Commission issued Broadcasting Public Notices CRTC 2007-127 and CRTC 2007-128, calling for applications for a broadcasting licence to carry on a radio programming undertaking to serve Edmonton and Red Deer, Alberta.

On 22 November 2007, the Commission issued Broadcasting Public Notice CRTC 2007-133, calling for applications for a broadcasting licence to carry on a radio programming undertaking to serve Drumheller, Alberta.

In response to these calls, the Commission has received a number of applications for licences to serve these markets.

Some of these applications are technically mutually exclusive. These applications are:

For Drumheller
