# 1. Hanover, Ontario Application No. 2008-1030-1

Application by **Bluewater Community Radio** to amend the licence of the Englishlanguage Type B community radio programming undertaking CFBW-FM in Hanover.

The licensee proposes to increase the effective height above average terrain (EHAAT) from 39.8 meters to 88.5 metres. Due to a loss of their present transmitter site, the licensee also proposes to relocate its transmitter 8 km to the west of Hanover.

The licensee notes that the coverage contours will be displaced closer to Walkerton as a result of the transmitter site location. The licensee argues, however, that the increase in EHAAT will minimize the impact on the service area for Hanover and should help maintain satisfactory signals.

The licensee also argues that the overall effect will be to provide more consistent and uniform coverage to the existing Hanover-Walkerton listening area.
