



## Broadcasting Public Notice CRTC 2005-26

*The Commission has received the following application. The deadline for submission of interventions/comments is 27 April 2005.*

1. **Barrie, Ontario**  
**Application No. 2004-1577-0**

Application by **Trust Communications Ministries** relating to the licence of radio programming undertaking CJLF-FM Barrie.

The licensee proposes to change the authorized contours by increasing the effective radiated power from 1,800 watts to an average effective radiated power of 18,700 watts (maximum effective radiated power 40,000 watts/antenna height of 226.1 metres).

The licensee wishes to improve the station's signal quality to listeners in Barrie as well as to those who commute between Barrie and Toronto.

The licensee also proposes to amend its licence by replacing the condition of licence relating to Canadian talent development expenditures (CTD) which reads:

- Spend a minimum of \$3,000 each year in direct costs on the promotion and development of local talent.

With the following conditions:

- Spend a minimum of \$5,000 each year in direct costs on the promotion and development of local talent.
- Contribute a \$500 scholarship each year to a student in the advertising course at Georgian College in Barrie.
