- 1. In Forbearance from the regulation of high capacity/digital data services interexchange private line services on certain additional routes, Telecom Decision CRTC 2006-54, 8 September 2006 (Decision 2006-54), the Commission forbore from regulating high capacity/digital data services interexchange private line (IXPL) services on certain additional routes pursuant to Follow-up Proceeding to Telecom Decision CRTC 97-20: Establishment of criterion and process for considering further forbearance from High Capacity/DDS interexchange private line services, Telecom Order CRTC 99-434, 12 May 1999.
- 2. Following the issuance of Decision 2006-54, the Commission was informed that a number of routes had been incorrectly labelled due to the misidentification of an exchange in Aliant Telecom Inc.'s (now operating as Bell Aliant Regional Communications, Limited Partnership) incumbent territory. Specifically, the exchange initially labelled "Beresford, NB" should have been correctly identified as "Bathurst, NB".
- 3. In this Erratum, the Commission is making corrections to the Appendix to Decision 2006-54 in order to correctly label the routes. A copy of the corrected Appendix is attached to this Erratum with changes highlighted in bold.
