#### 1. **Across Canada** **Application No. 2006-0694-9**

Application by **The Sports Network Inc.** to amend the broadcasting licence of its national English-language specialty programming undertaking known as The Sports Network (TSN).

Pursuant to Broadcasting Decision CRTC 2006-197, *Complaint by the Canadian Broadcasting Corporation concerning the simultaneous distribution of multiple feeds of The Sports Network*, 23 May 2006, TSN has applied to amend condition 1(d) of its licence which reads:

(d) The licensee may distribute separate regional programming in place of its national service to affiliated distribution undertakings provided that the hours devoted to such regional programming do not exceed 10% of the licensee's quarterly program schedule.

By adding:

The licensee may also distribute such multiple feeds of its service in a single region on a digital-only basis.
