Application by **1158556 Ontario Ltd.** to renew the licence of the commercial radio programming undertaking CHIM-FM Timmins and its transmitters CHIM-FM-1 North Bay, CHIM-FM-2 Iroquois Falls, CHIM-FM-3 Kirkland Lake, CHIM-FM-4 New Liskeard, CHIM-FM-6 Sault Ste. Marie, CHIM-FM-7 Elliot Lake, CHIM-FM-8 Wawa, CHIM-FM-9 Chapleau, CHIM-FM-10 Kapuskasing, Ontario and CHIM-FM-5 Red Deer, Alberta, expiring 30 November 2007.

It appears to the Commission that the licensee may have failed to comply with section 9(2) of the *Radio Regulations, 1986* concerning the provision of annual reports for the years 2001, 2002, 2003 and 2004 and with its condition of licence relating to financial contributions to be made to Canadian Talent Development for broadcast years 2001 through 2006.

The licensee proposes to devote, by condition of licence, 15% of all musical selections from category 3 (specialty format) to Canadian musical selections.

The Commission will consider the interventions already received, accepted and filed on the public file for Public Notice 2007-55 as well as other interventions received in the context of this Public Notice.
