Application by the **Canadian Broadcasting Corporation** (CBC) to amend the licence of the national French-language specialty programming undertaking known as Le Réseau de l'Information (RDI).

The licensee proposes to make the above-noted service available for distribution in high definition format.

In accordance with the framework set out in *Regulatory framework for the licensing and distribution of high definition pay and specialty service*, Broadcasting Public Notice CRTC [2006-74](#), 15 June 2006, programming on the analog service and on the upgraded service will be comparable, that is, not less than 95% of the video and audio components will be the same, exclusive of the commercial messages and of any part of the service carried on a subsidiary signal. Further, all programming making up the 5% allowance will be provided in HD.
