In accordance with the framework set out in *Regulatory framework for the licensing and distribution of high definition pay and specialty service*, Broadcasting Public Notice CRTC [2006-74](#), 15 June 2006, programming on the analog service and on the upgraded service will be comparable, that is, not less than 95% of the video and audio components will be the same, exclusive of the commercial messages and of any part of the service carried on a subsidiary signal. Further, all programming making up the 5% allowance will be provided in HD.

The licensee advises that it is currently authorized to distribute its service in high definition until 15 July 2008, and its broadcasting licence will expire on 31 August 2010. Consequently, it would like the same expiry date for the high definition authority.
