The licensee is applying to renew its licence including the following conditions of licence related to the broadcasting of ethnic programming as set out in the current licence:

By condition of licence, the licensee must provide programming in each broadcast week directed to a minimum of 20 cultural groups in a minimum of 15 different languages; and

The licensee is authorized, by condition of licence, to use a subsidiary communications multiplex operations (SCMO) channel for the purpose of broadcasting a predominantly Korean-language radio service.

As well, the licensee proposes to delete the following condition of licence:

The licensee must not broadcast any ethnic programming directed to the Chinese community during the 6 a.m. to 3 p.m. period on weekdays;

And replace it with the following condition of licence:

The licensee must not broadcast any ethnic programming directed to the Chinese community in the Cantonese dialect during the period 6 a.m. to 3 p.m. period on weekdays.

The Commission notes that the licensee intends to broadcast programming in the Mandarin dialect during this time period.
