Application by the **Canadian Broadcasting Corporation** relating to the broadcasting licence for the English-language television programming undertaking CBAT-TV Fredericton, New Brunswick.

The licensee proposes to amend the authorized contours of its transmitter CBAT-TV-1 Bon Accord, New Brunswick by decreasing the average effective radiated power from 54,700 watts to 32,300 watts and by decreasing the effective height of antenna above average terrain from 346.5 metres to 320.4 metres. The location of the transmitter remains unchanged. These changes will result in an increase of coverage south of Bon Accord and a decrease of coverage in the northwest part of the province.

The applicant indicated that, while this increase in coverage south of Bon Accord would result in the provision of service to an additional 6,740 potential Anglophone viewers, the decrease in the northwest part of the province would result in the loss of coverage for 19,615 Francophones. Furthermore, the applicant stated that, according to BBM Canada's Fall 2008 survey, only 5% of households in the whole of Madawaska County, which include all affected communities, rely on over-the-air signals for their television service.
