



Broadcasting Notice of Consultation CRTC 2009-330

Ottawa, 4 June 2009

Call for comments on proposed amendments to the Exemption order for new media broadcasting undertakings

1. The Commission proposes to amend the Exemption order for new media broadcasting undertakings, set out in Appendix A to Public Notice 1999-197. Specifically, the Commission proposes to amend the above-mentioned exemption order so as to address the following matters:
 - an expansion of the definition of new media broadcasting undertakings to encompass all Internet-based and mobile point-to-point broadcasting services;¹
 - the introduction of an undue preference prohibition on new media broadcasting undertakings; and
 - the introduction of a requirement for new media broadcasting undertakings to report to the Commission, upon request, information relevant to their operations.
2. The proposed amendment would reflect the determinations set out in Broadcasting Regulatory Policy 2009-329, also issued today. In that document, the Commission stated its intention to conduct a follow-up public proceeding on measurement tools and standards for the monitoring and reporting of broadcasting activities in new media. That proceeding will provide interested parties an opportunity to comment on specific proposed reporting requirements.

Call for comments

3. The proposed amendment to Appendix A to Public Notice 1999-197 is appended to this notice. The Commission invites comments on the wording of that proposed amendment. The Commission will accept comments that it receives on or before **6 July 2009**.
4. The Commission will not formally acknowledge comments. It will, however, fully consider all comments, and they will form part of the public record of the proceeding, provided that the procedures for filing set out below have been followed.

Appendix to Broadcasting Notice of Consultation CRTC 2009-330

Amendment to the Exemption order for new media broadcasting undertakings

The final sentence of the Exemption order for new media broadcasting undertakings, which is set out in Appendix A to *Exemption order for new media broadcasting undertakings*, Public Notice CRTC 1999-197, 17 December 1999, which describes those undertakings falling within that exemption order and which reads as follows:

New media broadcasting undertakings provide broadcasting services delivered and accessed over the Internet, in accordance with the interpretation of “broadcasting” set out in Broadcasting Public Notice CRTC 1999-84/Telecom Public Notice CRTC 99-14, *Report on New Media*, 17 May 1999.

is replaced by the following:

Description of a new media broadcasting undertaking

1. The undertaking provides broadcasting services, in accordance with the interpretation of “broadcasting” set out in *New Media*, Broadcasting Public Notice CRTC 1999-84/Telecom Public Notice CRTC 99-14, 17 May 1999, that are:
 - a. delivered and accessed over the Internet; or
 - b. delivered using point-to-point technology and received by way of mobile devices.
2. The undertaking does not give an undue preference to any person, including itself, or subject any person to an undue disadvantage. In any proceeding before the Commission, the burden of establishing that any preference or disadvantage is not undue is on the party that gives the preference or subjects the person to the disadvantage.
3. The undertaking submits such information regarding the undertaking’s activities in broadcasting in new media, and such other information that is required by the Commission in order to monitor the development of broadcasting in new media, at such time and in such form, as requested by the Commission from time to time.
