Application by **Média de Novo Inc.** for a broadcasting licence to operate a national English-language programming undertaking.

The applicant proposes to insert advertising (1) in the local availabilities of non-Canadian programming services distributed by Canadian broadcasting distribution undertakings and (2) over advertisements on Canadian stations distributed in distant markets, subject to agreements with conventional television stations.

The applicant also proposes to direct 70% of the revenues derived from the sale of the local availabilities of non-Canadian services to a new fund that it will establish, to be distributed to licensed private Canadian programming undertakings and to fund advanced media research activities. The applicant further proposes that the Commission permit it to use some portion of that amount to offset the capital costs of expanding its targeted advertising capabilities.



The application was published in Broadcasting Notice of Consultation CRTC 2009-803, 23 December 2009 (Notice of Consultation 2009-803), for the 22 February 2010 hearing and was later withdrawn in Broadcasting Notice of Consultation CRTC 2009-803-1, 12 February 2010.

The Commission will consider the interventions and replies for this item already accepted and placed on the public file for the 22 February 2010 hearing, as well as other interventions received in the context of this hearing.

The applicant updated its application in letters dated 12 April and 19 May 2010 which are available as part of the public file for this application. Interveners need not reiterate comments made in response to Notice of Consultation 2009-803. Comments in this proceeding are to focus on any additional information provided by the applicant in the above-noted letters or in its reply to comments submitted in response to Notice of Consultation 2009-803.
