Application by the **Canadian Broadcasting Corporation (CBC)** for a broadcasting licence to operate an English-language regional television programming undertaking in Yellowknife.

The CBC is currently authorized to operate CFYK-TV Yellowknife and its transmitters as a radiocommunication distribution undertaking (RDU). The CBC stated that it now wished to operate its RDU as a regional television station.

The CBC stated that CFYK-TV and all of its related transmitters were currently operating under an RDU licence due to a historical anomaly, which did not alter the fact that CFYK-TV was in every respect a regional television station and has been since its inception in 1979.

Additionally, the CBC is requesting that CFYK-TV be eligible to participate in the Local Program Improvement Fund (LPIF), retroactive to 1 September 2009.

CFYK-TV currently provides on average 10 hours per week of local programming. Its news programming, Northbeat and Igalaq (broadcast entirely in Inuktitut), is dedicated to reporting on news events that happen in the North.

The CBC stated that the technical parameters and the authorized contours of CFYK-TV and its transmitters listed below will not change.

As stated in *A group-based approach to the licensing of private television services*, Broadcasting Regulatory Policy CRTC 2010-167, 22 March 2010, the Commission does not intend to renew authorizations for full-power analog transmitters operating in the markets mandated for digital conversion beyond 31 August 2011.

## **Public participation**

### **Deadline for interventions**

**27 October 2010**

The intervention must be received by the Commission and by the applicant on or before the above-mentioned date. The Commission cannot be held responsible for postal delays and will not notify a party whose intervention is received after the deadline date. The intervention will not be considered by the Commission and will not be part of the public file.

Interventions will be considered by the Commission and will form part of the public record of the proceeding without further notification to intervening parties, provided the procedure set out below has been followed. Parties will be contacted only if their submissions raise procedural questions.

A true copy must be sent to the applicant, and proof that this has been done must accompany the intervention sent to the Commission.

The Commission advises those who file and serve by electronic mode to exercise caution when using e-mail for service of documents or notification, as it may be difficult to establish that service has occurred.

Parties must ensure that, before initiating service through electronic mode, they will be able to satisfy the Commission, upon request, that service of the notification was completed.

Submissions longer than five pages should include a summary.

Each paragraph of the submission should be numbered. In addition, where the intervention is filed by electronic means, the line **\*\*\*End of document\*\*\*** should be entered following the last paragraph of the document, as an indication that the document has not been damaged during electronic transmission.

Interventions should clearly identify the application referred to and indicate whether parties support or oppose the application, or, if they propose changes to it, include the facts and grounds for their proposal.

All information that parties provide as part of this public process, except information granted confidentiality, whether sent by postal mail, facsimile, e-mail or through the Commission's website at [www.crtc.gc.ca](http://www.crtc.gc.ca), becomes part of a publicly accessible file and will be posted on the Commission's website.
