Preamble

The Commission has received 20 licence renewal applications from pay-per-view, video-on-demand and specialty services as well as community television stations operating under licences that expire on 31 August 2014. As part of its examination of these applications, the Commission will consider the licensees' requests with respect to their regulatory requirements (e.g. conditions of licence), address apparent noncompliance issues and determine the length of the next licence terms. The Commission notes that it may decide to issue licence terms of varying lengths or adopt other measures, such as the imposition of new conditions of licence depending on a number of factors, including the requests made by the applicant, non-compliance issues and interventions received in response to this notice.

The applications are organized into the following groups:

a) Terrestrial pay-per-view television services

A pay-per-view (PPV) service is a scheduled programming service that is provided to subscribers on a pay-per-view basis. A terrestrial PPV service may only be distributed by a terrestrial broadcasting distribution service (BDU), such as a cable or digital subscriber line-based service.

b) *Direct-to-home pay-per-view television services*A direct-to-home (DTH) PPV service is a PPV that may only distributed by a DTH satellite BDU.

c) Video-on-demand services

Video-on-demand services allow viewers to select individual programs to view at the time of their own choosing. While the programs on these services are normally offered on a per-program basis for a fee, they may also be offered for free or be included as part of the offering of a linear pay or specialty service.

d) Specialty Category B services

Specialty Category B (formerly Category 2) services offer programming in a particular genre. Category B services are not necessarily made available by all BDUs as their distribution is secured through terms and conditions negotiated between BDUs and the programming services.

e) Community television stations

Community television stations are not-for-profit organizations, the structure of which provides for membership, management, operation and programming primarily by members of the community.

The Commission will examine these issues and determine if sanctions will be imposed in an attempt to rectify the situation, such as new conditions of licence of licence or a shorter licence term.
