Video-on-demand service

*The Commission **approves** an application for a broadcasting licence to operate a national video-on-demand service.*

Application

1. Gold Line Telemanagement Inc. (Gold Line) filed an application for a broadcasting licence to operate a national video-on-demand (VOD) service. The Commission did not receive any interventions regarding this application.
2. Gold Line is a corporation wholly owned and controlled by Mr. Ata Moeini.
3. The applicant indicated that the new VOD service would consist primarily of current titles from Hollywood studios and Canadian producers, including movies and episodes of current television series that are available only to VOD services. The programming would be drawn primarily from program categories 2(b) and 7, but could also include programming from categories 8(a), 9, 10, 11(a) and 11(b).
4. The applicant indicated that it would adhere to the standard requirements for VOD services set out in Broadcasting Regulatory Policy 2014-444, as amended by the Commission in the proceeding initiated by Broadcasting Notice of Consultation 2015-87.¹
5. Gold Line confirmed that it would make its VOD program offering available to customers in both official languages. While the programming would be predominantly in English, the applicant made a commitment to offer some programming in French.
6. In regard to contributions to Canadian programming, licensees of VOD undertakings are required, by condition of licence, to make a contribution equal to 5% of their gross revenues to the Canada Media Fund or to an independent production fund that is certified

by the Commission. Gold Line indicated that it would direct its required contribution to the Canada Media Fund.

Commission's analysis and decision

7. The Commission is satisfied that the application complies with the licensing framework for VOD services set out in Broadcasting Regulatory Policy 2010-190 and with all applicable requirements set out in Broadcasting Regulatory Policy 2015-355. Accordingly, the Commission **approves** the application by Gold Line Telemanagement Inc. for a broadcasting licence to operate a national video-on-demand programming undertaking. The licence will expire 31 August 2022. The licensee shall adhere to the **conditions of licence** set out in Appendix 2 to Broadcasting Regulatory Policy 2015-355, as well as to the **conditions** set out in the broadcasting licence for the undertaking. The standard expectations and encouragement applicable to this licensee are also set out in that regulatory policy.
8. The licence for this undertaking will be issued once the applicant has informed the Commission in writing that it is prepared to commence operations. The undertaking must be operational at the earliest possible date and in any event no later than 24 months from the date of this decision, unless a request for an extension of time is approved by the Commission before **1 February 2018**. In order to ensure that such a request is processed in a timely manner, it should be submitted at least 60 days before this date.
