# HD Workshop in BC, June 29th 2017

The purpose of this workshop is to educate and train ZoomerMedia's Mosaic partners with the technical requirements and know-how for a smooth transition to HD output. Mosaic representatives and their technical staff were both in attendance. Fontana Media conducted the workshops for Toronto-based and BC-based clients. Topics discussed were as follows:

## A. HD Overview

- a. Explain use and advantages of the industry standard XDCAM HD format.
- b. Video Codecs and file delivery formats. How failure to follow specifications can introduce delays in processing and can affect quality checking / screening.
- c. Resolution, frame rate and bitrate. How these elements can affect the video quality and the file size.
- d. Alternative format if HD is not available yet.

#### B. Technical Specifications

- a. Interlaced video and field dominance. What can go wrong?
- b. H264/AVC MP4 formats and challenges related to lack of standardizations.
- c. How 95% of software is capable of producing acceptable broadcast formats.
- d. Video file layout. File naming, slates black pad before and after video.
- e. Aspect ratios: How the service providers get the AFD codes to automatically adjust the frame size for SD down conversion.
- f. Handling mixed aspect ratio content.
- g. Delivery options: Pros and cons of FTP and different cloud service. Future plans.

#### C. Question and Answer

- a. Producers and their technical staff were given the opportunity to ask questions and clarifications about the topics discussed.
- b. Challenges and difficulties. Participants presented the challenges they face in the transition to HD output. Some concerns were addressed during the session while some requires follow through.

#### D. Follow-up consultation

- a. Mosaic partners were advised that any future questions and concerns will be answered by Technical Support.
- b. Technical Support will continue to assist until concerns are addressed.

The CARP Writer for Health Residency Program has inspired and encouraged a new group of Canadian writers and has opened avenues to diverse people and communities. The benefit of

enhanced mental health and well-being through honing the craft of writing by program participants adds much to the value of this unique learning opportunity.

John Vaillant served as the 2017 Writer in Residence. Mr. Vaillant is a best-selling, award-winning author of both fiction and non-fiction. He brought a wealth of experience as a public speaker, teacher and mentor. His focus on environmental concerns and social justice, along with his experience in a range of genres and forms and markets, made him a particularly good candidate.

During his term, he worked one-on-one with 36 learners, and reached many more during his presentations, both in-person and online, held in Edmonton in February and April. Mr. Vaillant's first presentation, titled "Reckoning the Present: Mediating the tension between the muse and the news" covered the challenge of the artist in the Trump era. How is art a political act? How is it a site of resistance? How does the writer take inspiration from current events? When is it time for the writer to turn away from current events, ignoring the nonstop stream of news in order to nurture the muse? Mr. Vaillant's talk was well attended and his timely lecture stimulated a very lively discussion.

Several students wrote letters of thanks, praising Mr. Vaillant's insight and generosity. His term at AU was a great success.
