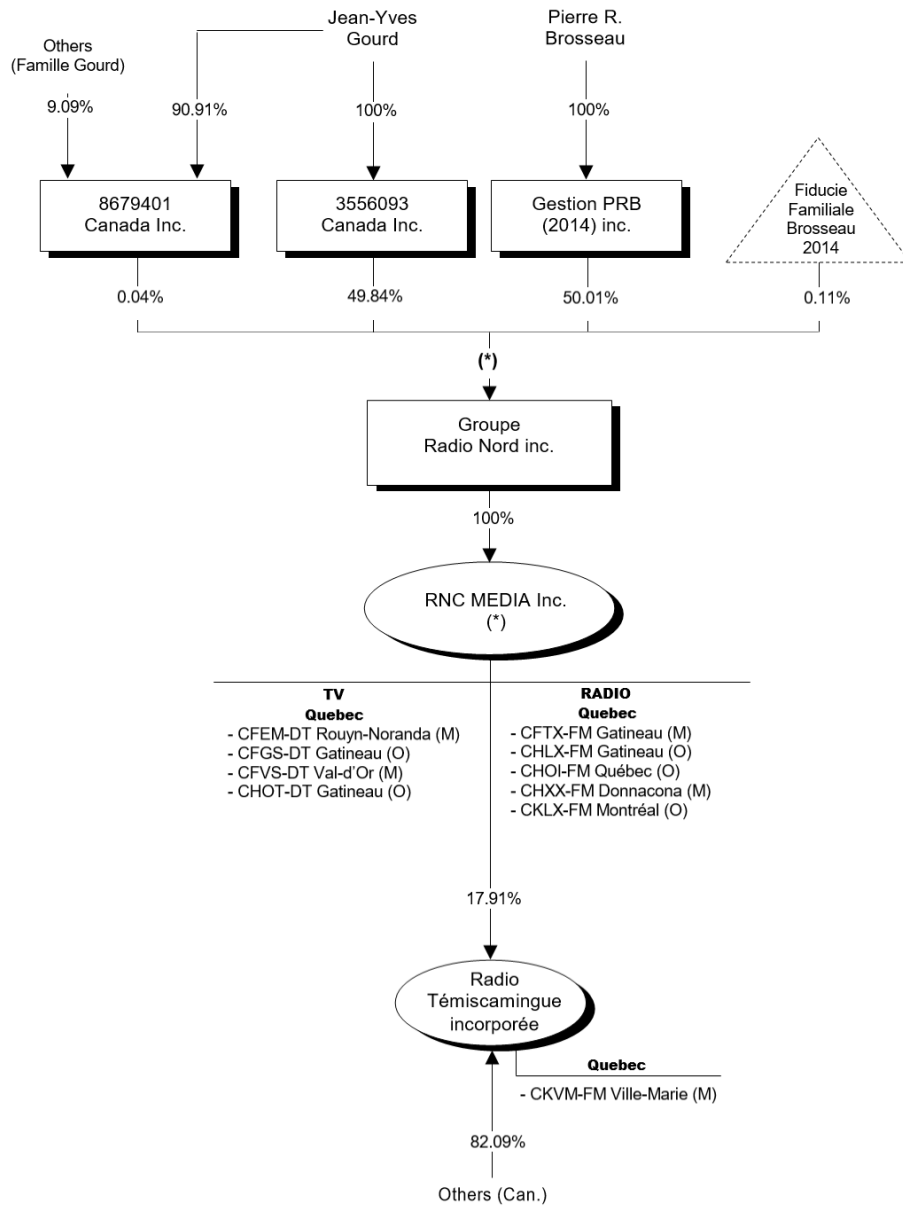

Administrative Approval – 2014-07-25 – approved a change in the ownership and effective control of RNC MEDIA Inc. (2014-0051-4)

CRTC 2018-122 – revoked the licence for CKRN-DT Rouyn-Noranda, Quebec and its transmitters, issued to RNC MEDIA Inc.

Amalgamation – 2018-08-27 – of RNC MEDIA Inc., Groupe Radio Antenne 6 inc. and 9150-2898 Québec inc. to continue as RNC MEDIA Inc.

CRTC 2018-396 – approved the acquisition by Cogeco Media Inc. of the assets of CHPR-FM Hawkesbury, CFGT-FM Alma, CKXO-FM Chibougamau, CHVD-FM Dolbeau, CJLA-FM Lachute, CJGO-FM La Sarre, CHRL-FM Roberval, CHOA-FM Rouyn-Noranda, CKYK-FM Saguenay and CHGO-FM Val d'Or from RNC MEDIA Inc.

CRTC 2019-125 – approved, subject to a condition of approval, the acquisition by Leclerc Communication Inc. of the assets of CHOI-FM Québec and CKLX-FM Montréal from RNC MEDIA Inc.

- 50.01% by Gestion PRB (2014) inc. which in turn is 100% held by Pierre R. Brosseau
- 49.84% by 3556093 Canada Inc. which in turn is 100% held by Jean-Yves Gourd
- 0.11% by Fiducie Familiale Brosseau 2014 and
- 0.04% 8679401 Canada Inc. which is 90.91% held by Jean-Yves Gourd and 9.09% held by other members of the Gourd Family

RNC MEDIA Inc. holds a 17.91% interest in Radio Témiscamingue incorporée. The other 82.09% is held by various Canadian minority shareholders.
