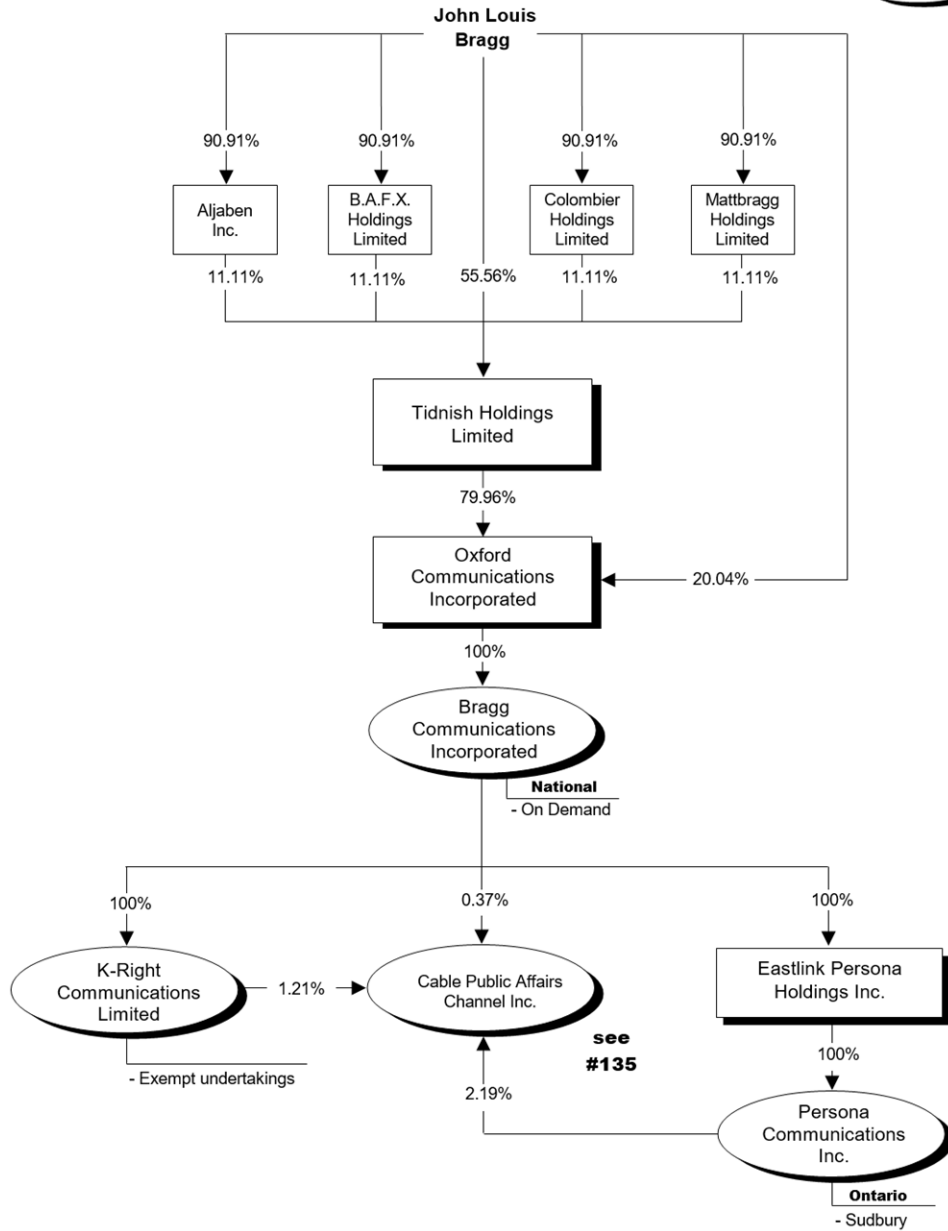


BRAGG (Eastlink) Distribution
