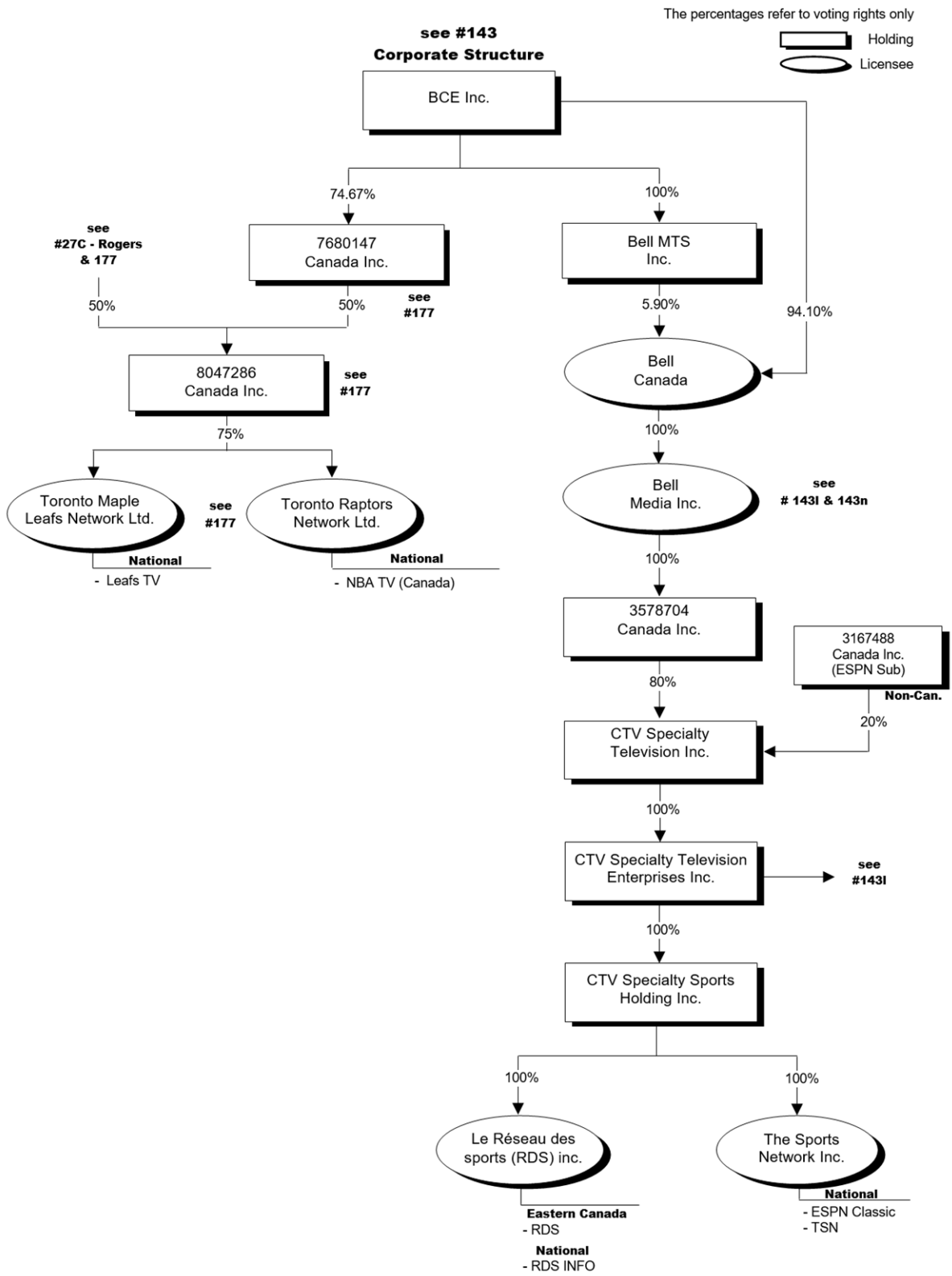

BCE Inc. holds the following:

- 100% of Bell MTS Inc.
- 94.10% in Bell Canada. The remaining 5.90% is held by Bell MTS Inc.
- 74.67% in 7680147 Canada Inc. (see chart 177)

Bell Canada holds 100% of Bell Media Inc. (See charts 143L and 143N)

Bell Media Inc. holds 100% of 3578704 Canada Inc.

3578704 Canada Inc. holds 80% in CTV Specialty Television Inc. The other 20% is held by 3167488 Canada Inc. (ESPN Sub), a non-Canadian corporation.

CTV Specialty Television Inc. holds 100% of CTV Specialty Television Enterprises Inc. (See chart 143L)

CTV Specialty Television Enterprises Inc. holds 100% of CTV Specialty Sports Holding Inc.

CTV Specialty Sports Holding Inc. holds 100% of Le Réseau des sports (RDS) inc. and 100% of The Sports Network Inc.

7680147 Canada Inc. holds 50% of 8047286 Canada Inc. The other 50% is held by a subsidiary of Rogers. (See charts 177 and 27C - Rogers)

8047286 Canada Inc. holds 75% in Toronto Raptors Network Ltd. and Toronto Maple Leafs Network Ltd. (See chart 177 for complete ownership)
