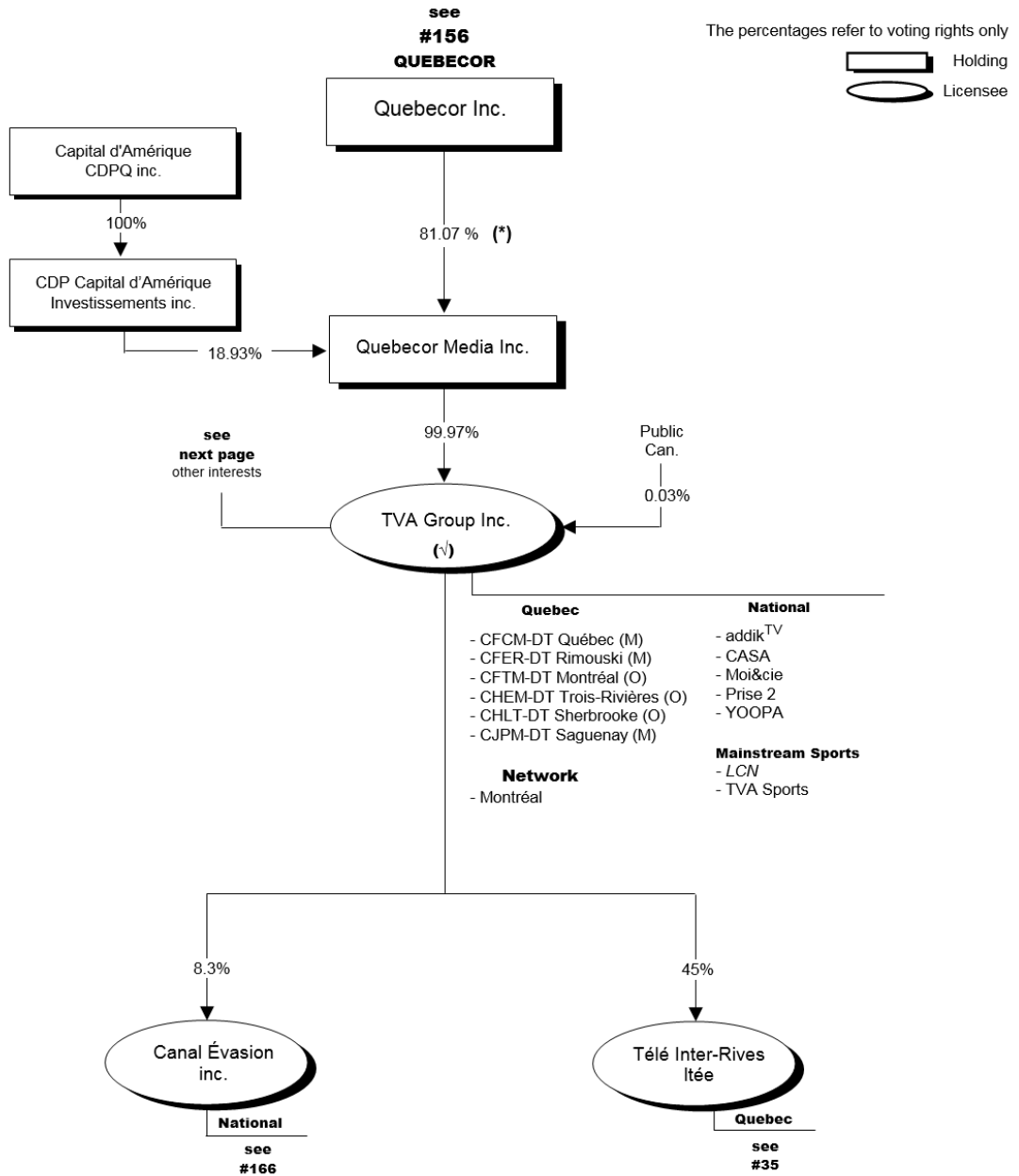

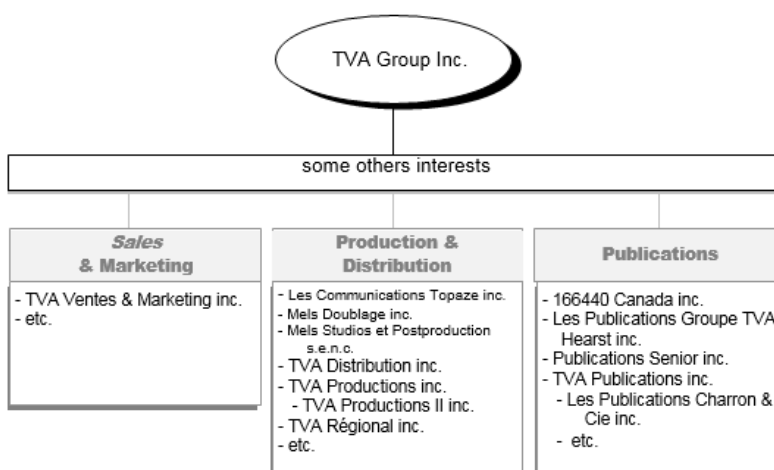

UPDATE

**Cancellation** – the specialty service to be known as Star Système (Decision CRTC 2010-753) did not implement within the prescribed timeframe.

**CRTC – 2015-48** – approved the amendment to licence CFER-TV Rimouski to replace its existing analog transmitter with a digital transmitter.

**Update** – 2015-02-17 – Sun News is no longer in operation.

**CRTC 2015-80** – approved the revocation of the licence for the national specialty Category C service Sun News issued to Sun Media Corporation and TVA Group Inc., partners in a general partnership carrying on business as Sun News General Partnership.
