

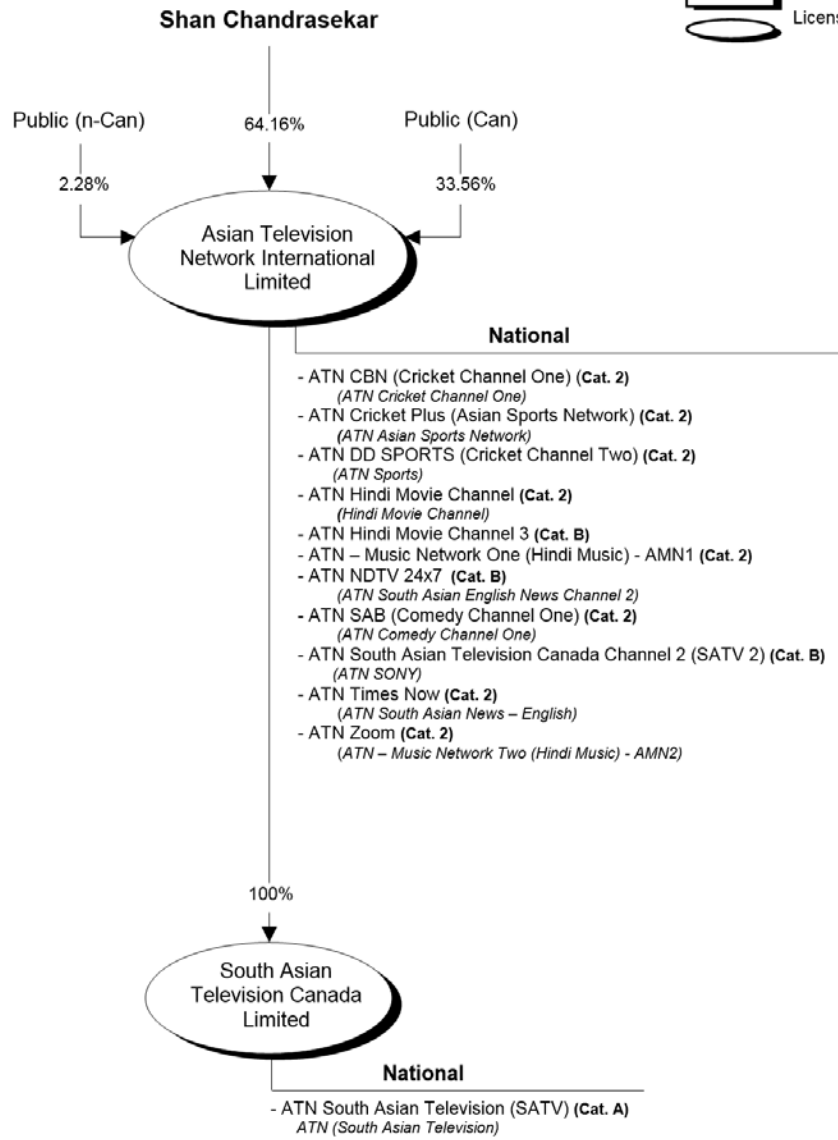

UPDATE

Update – 2014-04-15 – the specialty service known as ATN South Asian English News Channel 2 changed name to ATN NDTV 24x7.

Update – 2014-10-14 – specialty service name change – ATN Comedy Channel One changed to ATN SAB TV, ATN – South Asian News – English changed to ATN Times Now and ATN Music Network Two changed to ATN Zoom.

Update – 2015-03-06 – various specialty service name changes as per information supplied by the licensee.

Update – 2015-05-12 – Asian Television Network International Limited did not implement ATN Caribbean Channel Two within the approved timeframe of 2 May 2015.

Update – 2015-11-18 – Asian Television Network International Limited did not implement ATN Hindi Movie Channel 4 and ATN Hindi Movie Channel 5 within the approved timeframe of 4 November 2015.

Update – 2016-09-01 – Asian Television Network International Limited did not implement ATN Urdu News Channel 1 within the approved timeframe of 15 December 2015.
