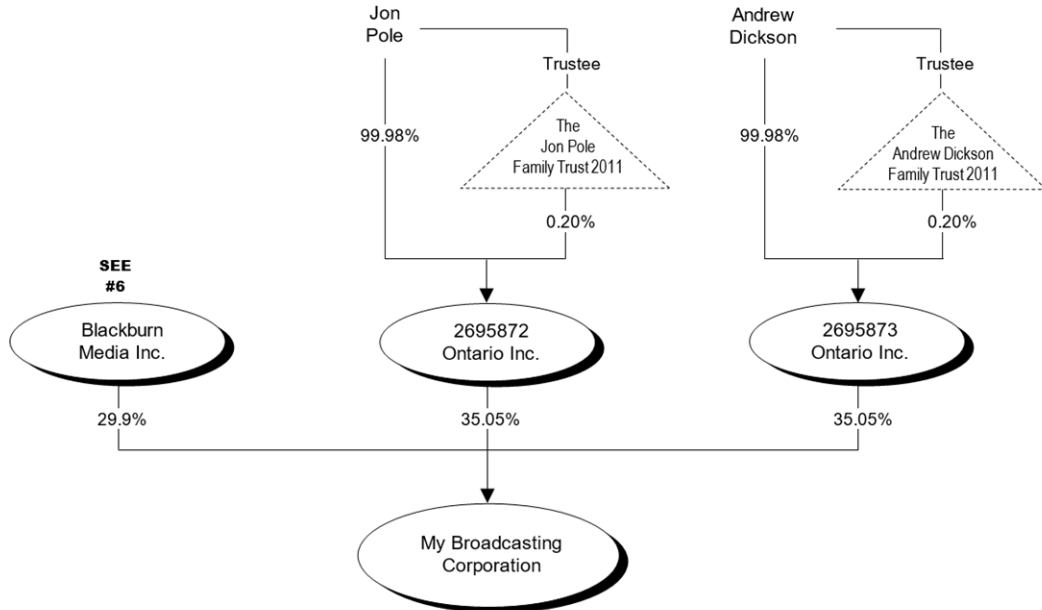

## **UPDATE**

**Update** – 2016-01-19 – CHMY-FM-1 Arnprior changed to CIMI-FM then changed to CFMP-FM.

**CRTC 2017-191** – approved a new commercial FM radio station in Simcoe.

**Administrative Approval** – 2019-08-01 – approved a change in ownership of My Broadcasting Corporation through the transfer of the shares held by the Jon Pole Family Trust and the Andrew Dickson Family Trust to their respective holding companies, 2695872 Ontario Inc. and 2695873 Ontario Inc.

**Administrative Decision CRTC L2021-0009** – approved a change in ownership and effective control of Perth FM Radio Inc. through the transfer of all of its issued and outstanding shares held by Brian Perkin and Perkworks Holdings Inc. to My Broadcasting Corporation.

**CRTC 2021-211** – approved the acquisition by Local Radio Lab Inc. of the assets of CIMA-FM Alliston, CJML-FM Milton and CKMO-FM Orangeville from My Broadcasting Corporation.

**NOTE: The transaction closed on 1 September 2021.**

**CRTC 2021-214** – approved the acquisition by Lakeside Radio Broadcasting Corp. of the assets of CIYN-FM Kincardine from My Broadcasting Corporation.

**Update** – 2021-09-01 – name change of Blackburn Radio Inc. to Blackburn Media Inc.

**Update** – 2022-06-23 – on 1 September 2021, Perth FM Radio Inc. amalgamated with and to continue as My Broadcasting Corporation.
