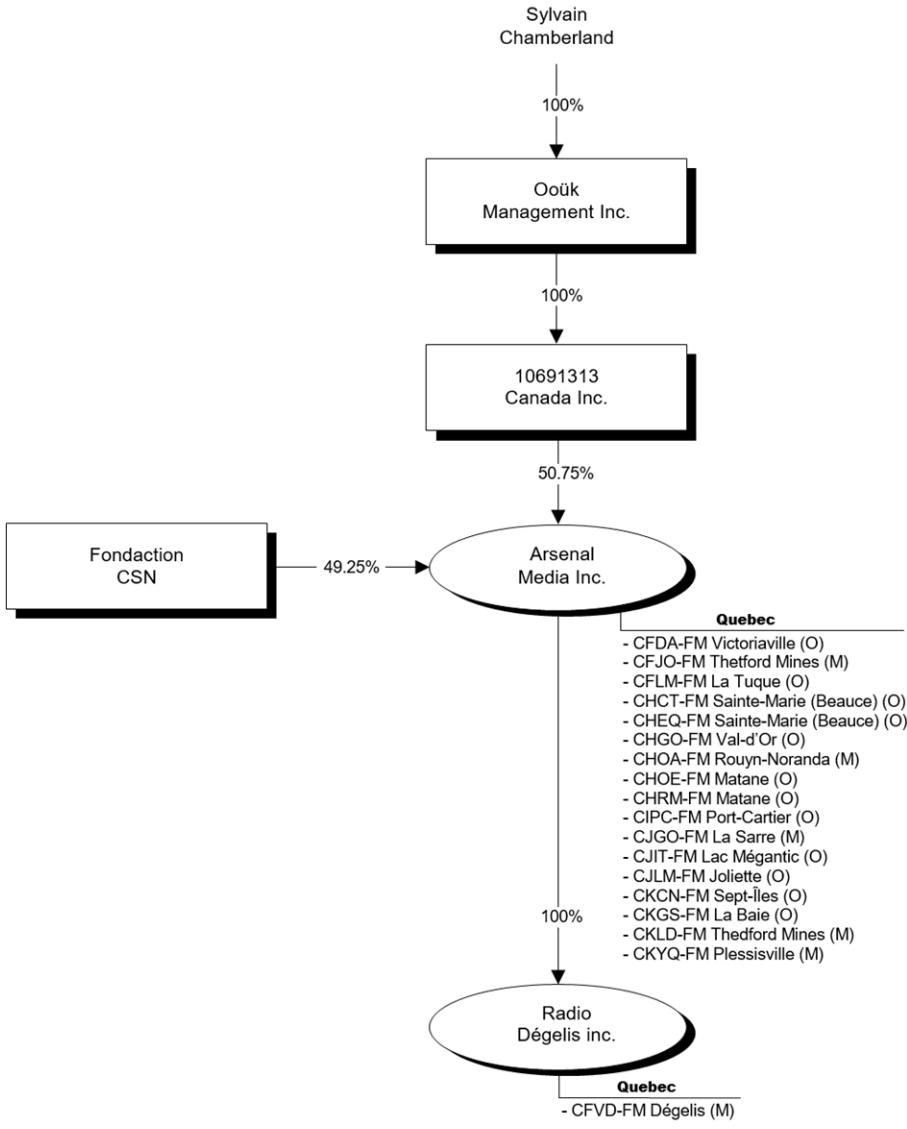

Update – 2022-01-13 – on 16 October 2021, 10679313 Canada Inc. changed its name to Arsenal Media Inc.

CRTC 2022-74 – approved the acquisition by Arsenal Media Inc. of the assets of the radio stations CHGO-FM Val d'Or, CHOA-FM Rouyn-Noranda and its transmitters, and CJGO-FM La Sarre and its transmitter, from Cogeco Media Inc.
