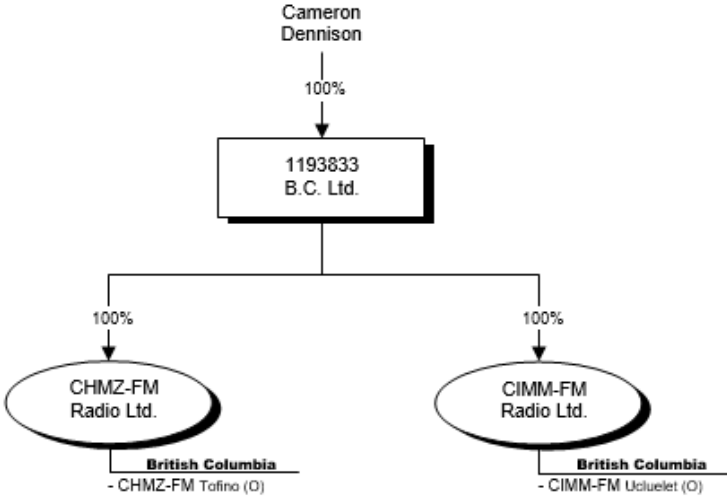

UPDATE

CRTC 2004-415 – approved a new FM radio station in Tofino to be operated in partnership by Umeek Human Resource Development Inc. and McBride Communications & Media Inc. under the name of West Island Radio Enterprises, a general partnership.

CRTC 2006-69 – approved a new FM radio station in Ucluelet to McBride Communications & Media Inc.

CRTC 2006-456 – approved, as part of an intra-corporate reorganization, the acquisition by CIMM-FM Radio Ltd. of the radio station CIMM-FM from McBride Communications & Media Inc.

CRTC 2006-643 – approved a new FM radio station in Pemberton to 0749943 B.C. Ltd.

CRTC 2008-117 – approved a new FM radio station in Port Moody to Matthew Gordon McBride, on behalf of a corporation to be incorporated.

Name change – 2007-01-15 – of 0749943 B.C. Ltd. to CFPV-FM Radio Ltd.

Incorporation – 2011-04-14 - of CKPM-FM Radio Ltd.

CRTC 2012-694 – approved the acquisition by CHMZ-FM Ltd. of the assets of the radio station CHMZ-FM Tofino from McBride Communications & Media Inc. and Umeek Human Resources Development Inc., partners in West Island Radio Enterprises, General Partnership.

CRTC 2020-76 – approved a change in ownership and effective control of CHMZ-FM Radio Ltd. and CIMM-FM Radio Ltd. through the transfer of all of their issued and outstanding shares held by Matthew G. McBride to 1193833 B.C. Ltd., a company wholly owned and controlled by Mr. Cameron Randall Dennison.
